Name of the work: Supply of Building materials for construction of Extension of Old College Building at North West Corner upto First Floor (Phase-I) during 2022-23

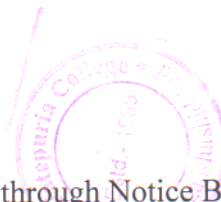
Description of the Materials to be supplied:

1. **Bricks:** 1st Class Bricks at work site with minimum strength of 10MPa(100 kg/cm²) (Requirement: 51600 Nos. approx)

- ❖ Date of opening Quotation – 02.09.2022 at 1 P.M.
- ❖ Earnest Money to be deposited- Rs.10000 by Demand Draft/Pay Order in favor of S.R.Fatepuria College
- ❖ Place of submission of Quotation - College Office Drop Box (Time: 11 A.M. to 1 P.M.)
- ❖ Time for supply of materials: 10 days after issue of order of supply or as directed by the college authority.

Terms & Conditions:

1. Rates to be furnished on their own letter head as per above schedule
2. Quotation without earnest money will be rejected.
3. Mode of measurement & specification of all the materials will be as per P.W.D norms.
4. As and when required as directed by Engineer in charge the materials will be tested to check the quality as per BIS norms. The cost of such test will be borne by the suppliers as directed by Engineer in Charge
5. Quotationers may furnish rates for all the listed items they are eligible or against any part of the same.
6. Order may be placed with any single agency for all the items or with more agencies separately, for different items for full or any part of the listed quantity.
7. The successful Quotationers will have to supply the materials within stipulated time, as per specifications with full satisfaction of the college authority, failing which his/their work order will be rescinded with forfeiture of earnest money & fresh order may be placed to other agency.
8. The successful supplier will have to submit bills in due course after completion the supply for prompt payment.
9. The successful quotationers will have to execute an agreement on non-judicial stamp paper of Rs.50/-.
10. If the dates coincide with any govt holiday, next working day will be considered
11. The agency should furnish competency and eligibility details i.e. Proof of Supply of Similar Items, GST or P.Tax, PAN Card & Trade License
